Since 1991, Mitch Fine has been at the forefront of the environmental building industry in California. In his work with government and industry, Mitch has been instrumental in the research, development and marketing of innovative energy efficient building products.

For 25 years, Mitch served as CEO of Armstrong Installation Service, the largest home improvement contractor in the San Francisco Bay Area. Armstrong's flagship product, spray polyurethane foam (SPF), is the world's leading energy efficient roofing material. Mitch also pioneered the development and marketing of low VOC lead free paints, for both the residential and commercial market.

Mitch's clients have included: City of Alameda Municipal Power, Valero Energy Corporation, State of California Energy Commission and Bay Area Rapid Transit District. Along with Governor Jerry Brown of California, Mitch was a founding member of the California Building Performance Contractors Association (CBPCA). CBPCA was one of the first organizations in the United States to be issued the Environmental Protection Agency's trademark- "Home Performance with Energy Star." In recognition of his leadership in the building trades, Mitch was appointed by Mayor Frank Jordan of San Francisco to oversee the development of the Country's first laws to protect children from lead paint poisoning.

Mitch currently serves on the Emeryville Citizens Oversight Committee, overseeing the design and construction of a model school facility project, funded by a \$125,000,000 public bond offering. In addition to being well respected by his peers as a General Building & Energy Conservation Contractor, Mitch has been active in Federal, State and local politics and is considered an expert in campaign finance.

Mitch is the former Controller (CFO) of the California Democratic Party, its former Budget Chairman and Finance Director. Mitch served as Treasurer for both Governor Jerry Brown in his winning bid for California Attorney General and for San Francisco Supervisor and Board President Angela Alioto. In 1987, Mitch Co -Chaired the largest grossing (up to that time) Presidential fundraiser in USA history.
